Demographic Projections: Summary of Methodology

I. Introduction / Background

The North Jersey Transportation Planning Authority (NJTPA), as a central element of its Regional Transportation Plan, presents three scenarios that each offer a different possible path for the region in terms of land use choices and the financial resources available for transportation investments. The three scenarios are Baseline, Plan 2035, and Aspirational. Three demographic scenarios were developed as input into the scenarios. This was done in coordination with member agencies. The New York Metropolitan Transportation Coordinating Council (NYMTC) provided certain data that was utilized in this process as described below.

The demographic (population, household, and employment) projections for the Baseline scenario are an extrapolation of adopted NJTPA demographic forecasts that assume similar land use patterns as today. The alternative Plan 2035 and Aspirational scenarios use demographic projections that reflect concentrating some additional level of future development into compact, mixed-use “Centers” to represent a stronger emphasis on the strategies associated with “smart growth” in the RTP. This memorandum provides an overview of the process to develop the demographic projections for each scenario.

II. Revised 2035 County-Level Projections

In March 2005, the NJTPA Board of Trustees adopted demographic forecasts for 2030. As part of the RTP planning process in 2008-09, NJTPA has prepared draft revised demographic projections, extending to 2035. The basic methodology for these projections started with the previous Board-approved forecasts and extrapolated current trends out to 2035. It did not involve a major vacant land data gathering process.

A. Population and Households

On the residential side, NJTPA started by extrapolating the previously-approved population forecasts from 2030 to 2035, i.e., applying the county-level growth rate from 2025-2030 to the 2030 forecast, in order to calculate a 2035 estimate. The NJTPA maintained this process for seven counties but, after reviewing the preliminary numbers, selected another process for the other six counties because they had uneven growth rates over twenty-five years and simply applying the rate from 2025-2035 period produced unrealistic results. For Essex, Monmouth, Somerset, Union, and Warren counties, the NJTPA applied the regional growth from 2025-2030, not the county-level growth rate, and for Morris County, NJTPA applied a 25-year regional growth rate since using the regional average growth rate produced results felt to be too high for the county to absorb.

After calculating the projected county-level population for 2035, the NJTPA calculated the projected households simply by applying the same household sizes from the previously-approved 2030 forecasts. Household size remained constant because no new analysis was available to suggest that this needed to be changed for the forecasts.

B. Employment

A major element of the revision process was updating the employment projections to reflect revised New Jersey regional employment data resulting from new econometric modeling for the tri-state region that the New York Metropolitan Transportation Council (NYMTC) conducted in summer 2008. This modeling effort assumed lower overall future regional growth, and, therefore, resulted in lower regional employment projections for 2035. Also, the NJTPA adjusted the previously estimated 2005 employment estimates (derived from the adopted 2030 forecasts) to reflect estimates from federal and state labor data and surveys. The NJTPA then applied the county-level employment distribution percentages (from the existing forecasts) to the revised regional totals for 2035. The resulting future employment projections for the counties in the NJTPA region are lower than the previously-approved forecasts due to a lower

starting point in 2005, a less robust forecast for the regional economy and lower national-level forecasts of elderly population and labor force participation rates. These revised lower employment projections are consistent with the previously-approved population forecasts because of expected decreased labor force participation rates.

The NJTPA circulated draft revised county-level projections to subregional planning partners and the Plan 2035 Technical Advisory Committee in December 2008.

Several counties offered suggestion for minor revisions to the county level projections. These county-level projections are incorporated in Table 1. This provided the basis for calculating new demographic projections at the traffic analysis zone (TAZ) and municipal levels for future scenarios to use in the RTP planning process, as the following section will describe.

III. RTP Demographic Scenarios – TAZ and Municipal-Level Projections

For the first time, the NJTPA regional transportation plan includes a scenario planning element. The process evaluated three land use and transportation investment scenarios: the Baseline Scenario, Plan 2035 Scenario, and Aspirational Scenario. Each scenario, for the year 2035, has associated demographic projections at the traffic analysis zone (TAZ) and municipal levels.

The Baseline scenario assumes that existing trends will continue, and it builds upon the revised county-level demographic projections that the previous section described. The Plan 2035 and Aspirational scenarios are alternative scenarios that also start with the revised county-level projections but reflect a greater concentration (than under Baseline) of future development into Centers. Plan 2035 is a “reasonable” future scenario which is the basis for the financially-constrained plan required by federal regulations. The Aspirational scenario reflects upper bounds for the region in terms of demographic shifts and transportation funding, and its demographic projections incorporate an even greater concentration of future development into Centers than under Plan 2035. The following sections provide more details on how NJTPA formulated the demographic projections for these scenarios.

A. Baseline Scenario

The Baseline scenario started with a straight trend analysis based on the 2005 Board Approved demographic average growth rate from 2005-2030. In addition, however, for the Highlands region, the calculations assumed that future development would occur in conformance with the Preservation Area designation and within available build-out calculations. The NJTPA also assumed that any municipalities with a projected 2025-2030 population increase of 10 people or less had reached build-out. Also, the NJTPA adjusted some projections in Monmouth County to reflect the fact that some towns had estimated 2008 population greater than the 2030 forecasts. Thus, in some cases, these constraints limited the growth in some communities as compared to the forecasts that would have resulted from using the trend projections from 2005 to 2035. In these instances, the NJTPA increased the projected population growth in other towns within the same county in order to maintain constant county-level totals. As previously discussed, household size was calculated by applying the 2030 household sizes to the projected 2035 population.

For employment, the NJTPA used a similar extrapolation process, using the revised 2035 county-level projections as control totals. This process considered the same build-out constraints as for population, except that no special adjustments based on recent estimates were necessary for Monmouth County.

B. Plan 2035 and Aspirational Scenarios

The projections for the Plan 2035 and Aspirational scenarios reflect slightly different assumptions about future growth in the Highlands Region than the Baseline scenario. For the Aspirational scenario, the projections assumed that future land development and accompanying population and employment growth in the Highlands Region would occur in full conformance with both the Preservation Area and Planning Area designations in the Highlands Master Plan. For the Plan 2035 scenario, projections for the Highlands Region assumed that future growth would be in full conformance with the Preservation Area (as with the Baseline scenario) and that approximately half of the Planning Areas would be in conformance. For all scenarios, NJTPA used the corresponding build-out calculations from the Highlands Council to constrain future development in some towns and increase future development by a similar amount for the non-Highlands towns in the same county.

1. Identifying Proposed Centers

The next step in the process of constructing the Plan 2035 and Aspirational scenarios was to identify proposed Centers. The NJTPA prepared an initial draft list of proposed Centers that included transit-oriented development opportunities identified through local visioning workshops held in the fall of 2008, as well as extensive interagency coordination with NJ Transit. In order to provide a more systematic approach to proposing centers, the NJTPA next identified several existing programs/policies relating to center-based development, including State Plan Center designation, Transit Village designation, Urban Enterprise Zone participation, and Urban Hub Tax Credit eligibility and included locations that are part of any of these programs. In addition, the list included other locations that are part of redevelopment zones or other regional or local center-based planning initiatives which were not initially identified. Examples of these initiatives include the Somerset County Transit-Oriented Development (TOD) study, the Greater New Brunswick Area Bus Rapid Transit (BRT) study, the Central Jersey US1 BRT study, and the West Trenton Line environmental assessment. The Plan 2035 forecasts contained at the back of this appendix identifies those municipalities listed as centers.

2. Classifying Centers

After identifying the proposed Centers, the next step in the process involved devising a simple classification system for estimating the extent of the increased future growth increment (i.e., the amount of growth greater than Baseline) for each Center. The system is based upon the “place types” utilized in the NJTPA Strategy Evaluation analysis, the growth forecast in the Baseline scenario, and on professional judgment. Each classification corresponds with a specified percentage of additional growth above the Baseline growth increment for the Center, as follows:

Class	% increase
1	125%
2	100%
3	75%
4	50%
5	25%
6	10%

For example, if a Center has a forecasted trend growth of 1,000 people and 2,000 jobs, and it has a classification of 4 (50% increase), then the revised growth increment under the Plan 2035 scenario will be 1,500 people and 3,000 jobs. The process of assigning a class to each Center allowed flexibility to adjust the individual Center designations in order to reflect unique circumstances. For some Centers, instead of a class designation, forecasts were overridden with a revised growth increment based on projections from known projects in development and professional judgment.

3. Plan 2035 versus Aspirational Scenario

The process included proposing Centers for both the Plan 2035 scenario and the Aspirational scenario. Most proposed Centers are included in the Plan 2035 scenario, but the NJTPA did identify a few additional potential Centers for the Aspirational scenario. The Aspirational scenario also includes all Centers included in the Plan 2035 scenario.

E. Calculating TAZ-Level Demographics

The next steps in the process were to prepare the alternative demographic projections by TAZ. The key steps included the following:

- Identify the corresponding TAZs for each Center, and calculate the 2005-2035 base growth increment for these TAZs.
- Apply the appropriate percentages for the Center classifications or apply the appropriate override growth amount for the Center and calculate the additional growth increment for the Centers.
- For each county, sum the additional growth calculated for each Center.
- Within each county, for all non-Center TAZs, reduce the base growth increment proportionally (by a constant percentage) based on each non-Center TAZ’s proportionate share of the total non-Center growth increment; this was done to produce the same county-level totals for the alternative projections as under the base projections.

The NJTPA applied this county-based process to the calculations for the Plan 2035 scenario. For the Aspirational scenario, this adjustment occurred on the regional level, so the calculations did not hold the county-level projections constant.

F. Completing the Projections

The NJTPA then completed a draft set of TAZ-level demographic projections for the Plan 2035 and Aspirational scenarios, and provided these projections to NJ TRANSIT and NJDOT for review and comment.

NJ TRANSIT conducted a thorough review of the projections and list of Centers, including cross-checking it against the agency's own list of plans and proposals for transit-oriented development. Based upon input from NJ TRANSIT, the NJTPA revised and finalized the projections to use in the regional transportation model for analysis.

The NJTPA then circulated the revised municipal-level Plan 2035 projections (TAZ data were aggregated into municipalities) to the subregions for review and comment. The largest overall concern was with the projections for the Highlands counties. Most counties with substantial areas in the Highlands region were concerned that they would not be able to absorb the projected growth. As previously described, the process involved constraining future growth in Highlands municipalities by build-out and re-allocating the excess growth increment to non-Highlands towns. In order to respond to concerns regarding unsustainable growth projections for some towns, the NJTPA adjusted the Plan 2035 demographic projections for the following three counties: Morris, Hunterdon, and Warren.

In Morris County, the NJTPA decreased the county population total by about 1.5% and did not change the employment total. For Hunterdon County, the NJTPA decreased the population control total by about 1.5% and the employment control total by about 2%. For Warren County, the NJTPA decreased the population control total by 1% and did not change the employment total. The Monmouth County Planning Board (MCPB) requested changes to the 2035 demographic forecasts. After discussions between MCPB and NJTPA concerning the requested changes, NJTPA redistributed some of the forecasts within the county to reflect anticipated growth opportunities in certain municipalities offset by lower growth in other areas of the county. The countywide population and employment totals remained unchanged. All these changes were made in coordination with county planning staff. The result of these adjustments was deemed to be reasonable and acceptable to the affected counties.

The NJTPA Board of Trustees adopted the Plan 2035 demographic projections as part of the approval of Plan 2035 in August, 2009.
