TOWNSHIP OF MONTCLAIR
ORDINANCE TO AMEND THE TRAFFIC ORDINANCE –
GROVE STREET SPEED LIMIT

October 18, 2016

The Council of the Township of Montclair in the County of Essex, does ordain:

Section 1. That an Ordinance entitled: An Ordinance to regulate vehicular traffic on the streets of the Township of Montclair, in the county of Essex, Adopted May 23, 2000, be further amended and supplemented to include the following:

§ 327-11. Speed limits.

Area S speed limits are hereby established at 25 miles per hour (mph) on all streets within the Township of Montclair unless designated otherwise herein. ~~upon~~ The following described streets or parts thereof are designated as exceptions to the area limit:

Bradford Avenue	25	Between Upper Mountain Avenue and Highland Avenue
<u>Grove Street</u>	<u>30</u>	<u>Entire Length</u>
Harrison Avenue	25	Entire length
Lorraine Avenue	25	Entire length
North Fullerton Avenue	25	Entire length
North Mountain Avenue	25	Entire length
Park Street	25	Entire length
South Fullerton Avenue	25	Entire length
South Mountain Avenue	25	Entire length
Undercliff Road	25	Entire length
Upper Mountain Avenue	30	From Mount Hebron Road to Town line
Upper Mountain Avenue	30	From Laurel Place to Watchung Avenue
Upper Mountain Avenue	35	From Watchung Avenue to Bloomfield Avenue
