

**RESOLUTION AUTHORIZING THE ACQUISITION OF  
ONE NEW 2016 FORD F350 RACK BODY VEHICLE  
THROUGH THE MORRIS COUNTY COOPERATIVE PRICING SYSTEM**

**WHEREAS**, the Township of Montclair is a party to a cooperative purchasing agreement with the Morris County Cooperative Pricing System, a cooperative purchasing program organized pursuant to the Local Public Contracts Law, N.J.S.A. 40A:11-10; and

**WHEREAS**, the Local Public Contracts Law authorizes a municipality to acquire goods and services through a duly formed cooperative purchasing system without advertising for bids; and

**WHEREAS**, the Township of Montclair is in need of acquiring one new 2016 Ford F350 Rack Body vehicle for use by the Department of Community Services; and

**WHEREAS**, the Morris County Cooperative Pricing System, Contract number 15-C, Item #27 has awarded a contract to Route 23 Auto Mall, 1301 Rt. 23 South, Butler, New Jersey 07405; and

**WHEREAS**, the procurement of goods and services through a cooperative purchasing program is an “open and fair” process under the New Jersey Pay-to-Play law, N.J.S.A. 19:44A-20.5 et seq.; now therefore,

**BE IT RESOLVED**, that the funds for this purchase have been appropriated in the 2015 Capital Budget, account number C-04-15-035-000-DPW; now therefore

**BE IT FURTHER RESOLVED**, by the Council of the Township of Montclair, in the County of Essex, that the Township of Montclair enter into an agreement with Route 23 Auto Mall, 1301 Rt. 23 South, Butler, New Jersey 07405 for one new 2016 Ford F350 Rack Body Vehicle in the amount of \$49,312.00 to be charged to the accounts above or as otherwise determined to be correct by the Chief Financial Officer’s pending certification of funds.
