WHEREAS, pursuant to N.J.S.A. 40A:11-12, the Township may, by resolution and without advertising for bids, purchase goods or services under the State of New Jersey Cooperative Purchasing Program for any State contracts entered into on behalf of the State by the Division of Purchase and Property in the Department of the Treasury; and

WHEREAS, the State of New Jersey has awarded a contract to CDW Government, Inc. ("CDW-G"), 230 North Milwaukee Avenue, Vernon Hills, NJ 60061 (Contract No.: NASPO Valuepoint DataCom Contract NVP #AR233 (14-19) A87720); and

WHEREAS, the Cisco Meraki Enterprise Cloud controlled Wi-Fi subscription plan provides an enterprise cloud controlled Wi-Fi access; direct access 24 hours a day, 365 days a year to specialized experts in the Cisco Technical Assistance Center (TAC); extensive self-help support through Cisco's online knowledge base, communities, resources, and tools which allows for the Office of Information Technology to efficiently handle all issues with the Township's secured internal/ external wireless ("Wi-Fi") networking connections; and

WHEREAS, CDW-G submitted a price quote dated February 10, 2020 (Quote # LFVV975) for the renewal of the Cisco Meraki Enterprise Cloud Controller Subscription for a period of five years from May 1, 2020 through April 30, 2025 in an amount not to exceed \$3,915.00 and hardware - Cisco wireless access points in an amount not to exceed \$12,615.00, total contract not to exceed amount of \$16,530.00. Funds for this purchase have been appropriated in the 2018 Information Technology capital budget, account number: 04-215-18-019-019, in an amount not to exceed \$16,530.00; and

WHEREAS, funds for this purchase have been appropriated in the appropriated in the 2018 Information Technology capital budget, account number: 04-215-18-019-019, in an amount not to exceed \$16,530.00; and

WHEREAS, the procurement of goods and services through the State of New Jersey Cooperative Purchasing Program is an open and fair process under the New Jersey Pay-To-Play Law N.J.S.A. 19:44A-20.4 et seq.; now therefore

BE IT RESOLVED, by the Council of the Township of Montclair, in the County of Essex, that a contract be awarded to CDW Government LLC of 230 North Milwaukee Avenue, Vernon Hills, Illinois 60061 for the renewal of the Cisco Meraki Enterprise Cloud Controller Subscription

and hardware for a period of five years commencing on May 1, 2020 and ending on April 30, 2025 in an amount not to exceed \$3,915.00 and hardware - Cisco wireless access points in an amount not to exceed \$12,615.00, total contract not to exceed amount of \$16,530.00.
