RESOLUTION AUTHORIZING EXECUTION OF A PROFESSIONAL ENGINEERING SERVICES AGREEMENT WITH SUBURBAN CONSULTING ENGINEERS, INC. FOR CONSTRUCTION ADMINISTRATION AND INSPECTION SERVICES IN RELATION TO THE 2020 SUB-AREA G SANITARY SEWER COLLECTION SYSTEM REHABILITATION

WHEREAS, the Township has a need to engage a professional engineering firm to provide engineering services in relation to the Construction Administration and Inspection Services for the 2020 Sub-Area G Sanitary Sewer Collection System Rehabilitation; and

WHEREAS, engineering services to be provided for this sanitary sewer collection system rehabilitation project would be in an amount not to exceed \$30,400.00 and include construction administration and inspection services; and

WHEREAS, the Local Public Contracts Law, N.J.S.A. 40A:11-5, authorizes the Township to enter into contracts for professional services without public bidding; and

WHEREAS, this contract is being awarded in accordance with the requirements of N.J.S.A. 19:44A-20.5 et seq.; and

WHEREAS, the Chief Financial Officer has certified that funds for the professional engineering services have been provided for as identified in the accounting records of the Township as follows:

WHEREAS, Suburban Consulting Engineers, Inc. has completed and submitted their Business Entity Disclosure Certification certifying that they have not made any reportable contributions to any political or candidate committee in the Township of Montclair in the previous one year period, and the subject contract will prohibit said corporations from making any reportable contributions during the term of this contract; now therefore

BE IT RESOLVED by the Council of the Township of Montclair, in the County of Essex, that the Township enter into an agreement with Suburban Consulting Engineers, Inc. of 96 U.S. Highway 206, Suite 101, Flanders, N.J. for the provision of professional engineering services, as stated in the March 2, 2020 proposal from Suburban Consulting Engineers, Inc. for the above-

named project in an amount not to exceed \$30,400.00. Funds for these professional engineering services are to be charged to account number 23-215-19-031-002; and

BE IT FURTHER RESOLVED that the Township Manager is hereby authorized to execute an agreement with Suburban Consulting Engineers, Inc. in accordance with this resolution, the form of which shall be approved by the Township Attorney; and

BE IT FURTHER RESOLVED that notice shall be published in the official newspaper stating the nature, service and amount of the agreement and that copies of this Resolution and the Agreement are on file and available for inspection in the Office of the Township Clerk.
